MA 202 Course Content

Course Description

Algebraic reasoning, introduction to statistics and probability, geometry, and measurement.

UK Department of Mathematics Professional Themes

This course will address the four themes of the conceptual framework for the UK professional education program: **research**, **reflection**, **learning**, and **leading**. Students will engage with fundamental ideas in mathematical *research*, *reflecting* on and analyzing core mathematical content that arises throughout mathematics at all levels. Students will develop as life-long mathematical *learners* who will be able to take active *leadership* roles in their future positions as professionals and citizens. The ultimate goal in addressing these four themes is to produce teaching

leaders who work together to improve student learning among diverse populations and improve education in Kentucky and beyond.

Unbridled Learning Initiatives and the Kentucky Core Academic Standards

This course will provide students an opportunity to advance their knowledge and mastery of the "tools" associated with Kentucky education reform, focusing on the content and practice standards outlined in the Kentucky Core Academic Standards. As students carry out projects and complete assignments that involve mathematical content underlying instructional activities for P-12 students in Kentucky schools, they will address one or more components of the Unbridled Learning initiatives.

Course Materials

Canvas

We will use Canvas as our primary resource for this course. The important tabs to be aware of for canvas are:

- Home: Front page with navigation links to the most frequently used parts of Canvas.
- Announcements: Important instructor announcements often instructions for common questions in the course, or reminders of upcoming assignments.

- MyLab and Mastering: Contains the graded homework assignments.

UK Rules and Regulations

Excused Absences

If you need to request an extension on an assignment due to an excused absence, please contact your instructor as soon as possible.

Students anticipating an absence for a major religious holiday are responsible for notifying the instructor - in writing - of anticipated absences due to their observance of such holidays no later than the last day for adding a class. It is almost always possible to notify your instructor of an excused absence before class. Students who have excused absences due to University-related trips or major religious holidays must inform the instructor prior to the absence and must complete all work prior to the absence. Students who are ill must inform the instructor of their absence(s) as soon as they return to class and they must provide documentation to demonstrate that the absence(s) was excused. Face Covering/Distancing Policy

The Senate Council endorses the following recommended syllabus statements for faculty teaching face-to-face courses.

- In accordance with University guidelines, students must wear UK-approved face coverings in the classroom and academic buildings (e.g., faculty offices, laboratories, libraries, performance/design studios, and common study areas where students might congregate). If UKapproved face coverings are not worn over the nose and mouth, students will be asked to leave the classroom.

- Students should leave enough space when entering and exiting a room. Students should not crowd doorways at the beginning or end of class.
- The instructor may choose to remove a mask when pedagogically necessary at the front of the classroom and behind a clear barrier. The instructor's mask will be replaced when it is no longer necessary to have it removed, or when the class meeting is complete.

Academic Integrity, Cheating, and Plagiarism

You should feel free to study with friends, but any work you submit for a grade should be your own work. This applies to all exams, quizzes, and writing assignments, with the exception of any

assignment that is specifically designated as a group assignment.

Per University policy, students shall not plagiarize, cheat, or falsify or misuse academic records. Students are expected to adhere to University policy on cheating and plagiarism in all courses. The minimum penalty for a first offense is a zero on the assignment on which the offense occurred. A plea of ignorance is not acceptable as a defense against the charge of academic dishonesty. In cases where students feel unsure about a question of plagiarism involving their work, they are obliged to consult their instructors on the matter before submission.

When students submit work purporting to be their own, but which in any way borrows ideas, organization, wording, or content from another source without appropriate acknowledgment of the fact, the students are guilty of plagiarism.

Plagiarism includes reproducing someone else's work (including, but not limited to, a published article, a book, a website, computer code, or a paper from a friend) without clear attribution. Plagiarism also includes the practice of employing or allowing another person to alter or revise the work, which a student submits as their own - whoever that other person may be. Students may discuss assignments among themselves or with an instructor or tutor, but when the actual work is done, it must be done by the student, and the student alone.

When a student's assignment involves research in outside sources or information, the student must carefully acknowledge exactly what, where, and how they have employed them. If the words of someone else are used, the student must put quotation marks around the passage in question and add an appropriate indication of its origin. Making simple changes while leaving the organization, content, and phraseology intact is plagiaristic. However, nothing in these Rules shall apply to those ideas, which are so generally and freely circulated as to be a part of the public domain.

Please note: Any assignment you turn in may be submitted to an electronic database to check for plagiarism.
